

Kenya GDP Workshop

08 May 2018 – 10 May 2018

The workshop was successfully conducted in **Nairobi**, Kenya, at the **Crowne Plaza Hotel**. The attendees were a mix of distributors from 8 different countries, NGOs, pharmacy students, hospital workers and County Managers (Kenya) which was quite a change from the previous workshops.

Experts from Amgen, Roche, GSK and Novartis presented the various GDP Topics during the workshop. The participants were engaged and really enjoyed the interactive workshop based sessions. We had roughly 8 to 10 people per breakaway group and at times people felt these groups were too big. Nonetheless, the feedback from these breakout groups was really good.

As per expectation, the IHS Warehouse tour was very successful. Due to the number of participants, questions could not be asked during the tour. All questions were addressed after the tour was completed.

Overall, the workshop was well received with **50%** of the participants rating the workshop as Excellent and **48%** of the participants rating the workshop as Very Good.

Below are some of the insightful questions raised during the workshop:

- 1. What is Rx360 doing regarding counterfeiters and the influx of sub-standard drugs into the market?
- 2. Is direct to consumer advertising regarding medicines legal?
- 3. What is the role of the press?
- 4. What should be done when a product for birth control actually causes abortions?
- 5. What should you do when a doctor writes the wrong prescription for a patient?
- 6. Do we need to map trucks, warehouse, fridges etc? This is very capital intensive? Are there local suppliers in Kenya?
- 7. How do we ensure storage conditions throughout the supply chain? Hospitals? Counties? The last mile is always the biggest challenge, but this comes at a cost.
- 8. Can companies give stability data to distributors? It was explained that this information needs to be held with the holder of the data, because all temperature excursions, which occurred all the supply chain needs to be included in the decision.



- 9. What is the guideline for storing temperature probes, should they be stored in water or oil?
- 10. When transporting cold chain products in vehicles, what temperature do you transport them at?
- 11. If you have a fleet of vehicles which are similar, can you use a matrix approach and qualify the worst case?
- 12. If all the systems are already in place, how will you qualify? You can do retrospective validation and OQ/PQ.
- 13. What is the minimum number of days for mappings?

Suggestions:

Perhaps look at being stricter with upfront registrations, e.g. introduce a nominal registration fee, to assist with reducing the "chancers".

As with all workshops the participants always request more time for discussion / understanding. We could perhaps do a dry run with the presenters to revisit the time allocations and confirm if there is in fact enough time for all topics

As per the feedback received from previous workshops the participants again requested that the local Regulators be included. Recommendation is that the Africa Working Group discuss the feasibility of hosting a Regulators workshop in 2018 for the various country groups.

Perhaps look at not providing memory sticks in future and rather look at sharing the presentations and supporting documents via Cloud Sharing Solution (for a limited time e.g. 3 days).
