

Topic-Focused Working Groups

Supply Chain Security Steering Committee: Identifies common gaps and opportunities to educate in the supply chain security and integrity.

Audit Operations Group: Provides guidance on all aspects of the Rx-360 Joint Audit Program.

Data Integrity: Develops processes, tools, and training to incorporate data integrity best practices.

Cell & Gene Therapy: Share best practices on how we approach cell and gene therapy suppliers while still in the clinical phase.

Legislative Guidances: Develops content and pathways for Rx-360 to engage with government authorities regarding these guidances.

Supplier Quality: Members from pharmaceutical companies and leading suppliers to the pharmaceutical industry.

Logistics Security: Logistics incidents that are security related involving pharmaceutical product.

Supplier Assessment Questionnaire Sub Team: The Rx-360 SAQ covers standard information that would be included in most supplier assessment questionnaires.

International Working Groups

Latin America: Concentrates on educational workshops in Spanishspeaking countries around GDPs & GMPs as well as supply chain issues specific to Latin America.

Africa & Middle East: Develops educational materials for use in Africa, to educate distributors in supply chain security.

Europe: Focuses on supply chain security in the European region. Topics covered may include BREXIT, COVID, Diversion, Parallel Trade, Issues with Turkey (diversion, counterfeit), Stolen product out of Italy, FMD and EFPIA.

Asia Pacific & India: Develops a vibrant network of regional/global companies, protects patient safety by sharing critical information, contributes to current Rx-360 workstream outputs with information specific to these regions, and influences regional regulatory activities to improve the transparency and integrity of the supply channels to protect patient health regionally and globally.




Rx-360 Joint Audit Program®

The Rx-360 Joint Audit Program[®] reduces the number of audits that must be performed and hosted.
